- 2) One copy of the Bid Proposal shall be filled in and submitted as the bid.
- 3) The Bidder, having the appropriate active license required by the State of California; and having carefully read and examined the plans, specifications, and all related bidding documents as prepared by Montgomery and Associates for the Groundwater Monitoring Wells Project for the Santa Margarita Groundwater Agency, having carefully and fully examined the site of the proposed work and all information available to bidder, and being familiar with all the conditions related to the proposed work, including the availability of materials, equipment, and labor, hereby offers to furnish all labor, materials, tools, transportation, services, and equipment necessary to complete the work of the described project in accordance with the Contract Documents, and to complete all requirements of the Contract Documents for the sums quoted in this Bid Proposal. Bidder agrees, if requested by Owner, to complete and sign the Contractor Qualification Questionnaire, furnishing all required attachments, and return it to Owner within ten (10) days of date of dispatch by Owner. If the bidder is selected as the apparent lowest responsible bidder, the bidder agrees, within ten (10) days after date of dispatch of Notice of Award, to sign and deliver the Contract, and to furnish the Performance Bond, the Payment Bond, Certificates of Insurance, and other required items. If awarded the Contract, the bidder agrees to complete the work within the number of calendar days specified by the Project Manager after the date of the commencement specified in the Notice to Proceed.
- 4) The bidder and subcontractors must meet the following requirements:
 - a) No contractor or subcontractor may be listed on a bid proposal for a public works project (submitted on or after March 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 (with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a).

- b) No contractor or subcontractor may be awarded a contract for public work on a public works project (awarded on or after April 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5.
- c) This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.
- 5) The bidder agrees that if the bidder is selected as the apparent lowest responsible bidder, and the bidder fails to sign the Contract and furnish (1) the **Performance Bond**, (2) the **Payment Bond**, (3) **Certificates of Insurance**, and (4) **other required items** within the time limit specified in the Contract Documents, the Owner may award the work to another bidder or call for new bids. In such event, the bidder shall be liable to the Owner for the difference between the amount of the disqualified bid and the larger amount for which the Owner procures the work plus all of the Owner's costs, damages, expenses and liabilities arising from bidder's failure to sign the Contract and/or furnish the required documents.

BID SCHEDULE

The undersigned will perform the work of the **Groundwater Monitoring Wells Project for the Santa Margarita Groundwater Agency** (Table 1¹ and Table 2 below²) as set forth in the Contract Documents, prepared by the **Owner** and Montgomery and Associates, and based on the following:

- 1. The Contractor's bid shall include all work set forth in the contract documents, including but not limited to: labor, materials, equipment, tools, construction equipment and machinery, fuel, utilities, transportation, portable toilets, and other facilities and services necessary for the proper execution and completion of the Work, whether temporary or permanent and whether or not incorporated or to be incorporated in the Work, including but not limited to: mobilization, site preparation, traffic control, utility clearance, borehole drilling, well installation, well development, surface completion, and demobilization.
- 2. Where quantities are shown, they are based on the engineer's estimates. Variations may occur between actual quantities and engineer's estimated quantities. The contract will be a lump sum contract. Payment will be based on lump sum bid amount(s) for work completed and no allowance will be made for variations between actual quantities and engineer's estimated quantities without express authorization of the Owner's Representative.
- 3. In the event that the product of a unit price and an estimated quantity does not equal the extended amount stated, the unit price will govern, and the correct product of the unit price and the estimated quantity shall be deemed to be the bid amount.

The scope of work may be reduced by the Owner for funding, budgetary considerations or unforeseen constraints. The Owner may, at any time and from time to time, order additions, deletions or other modifications to the Work (a "Work Change") by submitting a written change order request to Contractor ("Change Order Request"). An additive change order will increase the cost of completing the work or increase the time within which it can be completed. A deductive change order will decrease the cost of completing the Work or the time within which it can be completed. Upon receipt of a duly authorized Change Order Request, Contractor shall perform any extra work, make any substitutions in the Work, or omit any portion of the Work required thereby and shall not thereafter perform any work or order materials that are inconsistent with such Change Order Request. Contractor or anyone acting for or on behalf of Contractor shall not be entitled to any additional compensation for any labor, materials or equipment performed or ordered after receipt of a duly authorized Change Order Request if the same are not consistent with the Change Order Request. Contractor shall (i) maintain records of all duly authorized modifications made to the Work, (ii) notify Owner's Representative of each such duly authorized modification immediately upon making the modification, and (iii) show such duly authorized modifications on a copy of the Plans and Specifications. Where feasible, the pricing for the Work Change should be based on the amounts set forth in the Contractor's bid, which include profit and overhead.

Furthermore, the undersigned acknowledges that the construction of the shallow monitoring well network and associated well completion reporting is to be completed by September 30, 2023, as required by the grant funding source described in Volume I (see Special Conditions).

¹ Note that we do not currently anticipate requiring geophysical logging for the shallow well network, so there is no Bid Item No. 5 in Table 1.
